WHEREAS The first cornerstone laid in the foundation of our Republic was "TO SECURE THESE RIGHTS GOVERNMEN"

ARE INSTITUTED AMONG MEN". In solidarity with the Republican Party of Texas, the Republican Party of Maricopa County,

Arizona, and their resolutions to reject the flawed results of the 2020 Presidential Election thereby defending against this attack of
the Constitutionally protected rights of the citizenry and the sanctity of our Republic:

AND WHEREAS We believe the 2020 Election violated Article 1 and 2 of the US Constitution, and as documented in Report Summary 19-DP-06, dated August 2020, titled "Information Systems Audit" produced by Montana Legislative Audit Division, documented multiple areas where Montana's Election System falls short of "Best Practices" leaving our election system at risk, an nationally, States circumvented their state legislatures in conducting elections in multiple illegal ways. These illegal acts combined to drastically impact States operating within the law, rendering a Constitutionally questionable election.

AND WHEREAS The 2000 Mules Documentary, using publicly collected evidence of geo tracking and municipal video surveillance, irrefutably proves election fraud occurred around the country during the 2020 election in the form of ballot trafficking through drop boxes;

AND WHEREAS In October 2020 Joseph Robinette Biden Jr. proclaimed the democratic party had developed "the most extensive and inclusive voter fraud organization in the history of American politics."
